RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Requesting Transfer of Certain BIA, Papago Agency Domestic Water and Wastewater Facilities

RES. NO. 188-83

WHEREAS, the Bureau of Indian Affairs has offered to transfer certain 1 domestic water and wastewater systems to the Papago Tribe 2 located in San Simon, Santa Rosa Ranch, Santa Rosa Boarding 3 School and Sells: and WHEREAS, the Papago Council has considered the offer and has determined 4 that it would be in the best interests of the Papago Tribe to 5 receive such systems; and 6WHEREAS, the Papago Council has established the Papago Tribal Utility 7 Authority (PTUA) with the necessary facilities, staff and resources to adequately and reliably operate and maintain 8 domestic water and wastewater facilities on the Papago 9 Reservation. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby request the Bureau of Indian Affairs to transfer the domestic 11 water supply and wastewater systems at the San Simon Elementary 12 School, Santa Rosa Ranch School, Santa Rosa Boarding School and 13 at the Sells Compound to the Papago Tribe to be operated and maintained by PTUA in accordance with their current Rules, 14 Regulations and Conditions of Service. 15 BE IT FURTHER RESOLVED that following an acceptable evaluation of PTUA's 16 ability to operate and maintain the aforementioned systems in accordance with current U.S.E.P.A. standards, the Bureau of Indian 17 Affairs is requested to negotiate with PTUA for the orderly transfer 18 of these systems together with any spare parts and or equipment 19 which may be on hand. The foregoing Resolution was duly enacted by the Papago Council on the 20day of November, 1983, at a meeting at which a quorum was present with a vote of <u>1440.0</u> for; <u>-0-</u> against; <u>-0-</u> not voting; and <u>2</u> absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (e) 21 and Section 3 (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to **2**3 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
