

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving Amendment to Gu Achi District)
(Budget)

RES. NO. 25-83

1 WHEREAS, the Gu Achi District proposed an original FY 1983 budget
2 of \$211,007.11 for 16 months, June 11, 1982 to September 30,
3 1983; and

4 WHEREAS, the Papago Council did on June 10, 1982 approve the Gu Achi
5 District Budget and authorized expenditures in accordance
6 therewith; and

7 WHEREAS, the Gu Achi District has expressed a need to amend and add
8 the sum of \$33,516.46 to its FY 1983 budget, to be expended
9 from funds in Gu Achi District's IIM Account totalling
10 \$605,654.50 as of January 31, 1983; and

11 WHEREAS, the purpose of such amendment is to purchase a truck,
12 maintenance and operation for the truck, insurance, driver,
13 and fringe benefits.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
15 approve the amendment of the Gu Achi District's FY 1983 budget as
16 expressed in the attached Resolution of its District Council
17 and does hereby authorize expenditures of funds in accordance
18 therewith.

19 The foregoing Resolution was duly enacted by the Papago Council on the 18th day
20 of February, 1983, at a meeting at which a quorum was present with a vote of
21 1148.0 for; 0 against; 0 not voting; and 2 absent,
22 pursuant to the authority vested in the Papago Council by Section 3 (h) of
23 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
24 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
25 Secretary of the Interior on January 5, 1937, pursuant to Section 16 of the Act
26 of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date
27 of its approval by the Superintendent of the Papago Agency and is subject to
28 review by the Secretary of the Interior.
