

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
( Superseding Resolution No. 10-83 )

RES. NO. 28-83

1 WHEREAS, Muriel Segundo and Julia Carrillo were terminated by the  
2 Executive Health Staff from their positions as Directors  
of Disease Control and Nutrition Improvement, respectively; and

3 WHEREAS, Mmes Segundo and Carrillo successfully appealed their  
4 terminations according to the Personnel Policies and Procedures  
5 Manual of the Papago Tribe; and

6 WHEREAS, the Tribal Chairman, in a letter to the Personnel Officer  
7 dated December 28, 1982 ordered that Officer to reinstate  
8 Mmes Segundo and Carrillo to the positions that they occupied  
9 before the termination, to award them all back pay accrued  
10 from the time of termination to the time of reinstatement,  
11 along with any accumulated leave, and to expunge any and all  
12 evidence of their improper termination from their personnel  
13 files; and

14 WHEREAS, during the pendency of Muriel Segundo's and Julia Carrillo's  
15 appeals, the same individuals who improperly terminated them  
16 acted to eliminate their positions from the EHS interim budget;  
17 and

18 WHEREAS, the Papago Council did address this matter in considering actions  
19 upon Resolution No. 10-83, but the Resolution fails to express  
20 the direction of the Council; and

21 WHEREAS, the Tribal Council strongly feels that the right of these two  
22 individuals to reinstatement in their former positions with  
23 full back pay and the other relief ordered by the Chairman  
24 in his letter of December 28, should not be defeated because  
25 of budgetary maneuvering on the part of the same people who  
26 were responsible for the improper termination.

27 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that the  
28 Chairman of the Papago Tribe is hereby instructed to implement  
29 the provisions of his letter dated December 28, 1982 in full.

30 The foregoing Resolution was duly enacted by the Papago Council on the 18th day  
31 of February, 1983, at a meeting at which a quorum was present with a vote of  
32 749.0 for; 175.0 against; 224.0 not voting; and 1 absent,  
pursuant to the authority vested in the Papago Council by Section 2 (e) and (f)  
of Article V of the Constitution and By-laws of the Papago Tribe of Arizona,  
as amended, ratified by the Papago Tribe on December 23, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review  
by the Secretary of the Interior and is effective as of the dates of its enactment  
by the Papago Council
