

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Telephone Service - Baboquivari, Gu Vo, Hickiwan

RES. NO. 31-83

1 WHEREAS, the Baboquivari, Gu Vo and Hickiwan Districts of the Papago  
2 Reservation have complained that they and their resident  
3 members have been refused or deprived of telephone service  
4 by the Mountain Bell telephone company, and have requested  
5 help from the Superintendent of the Papago Agency to have  
6 telephone service provided to their respective areas.


7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does  
8 hereby request the help of the Papago Agency to secure  
9 telephone service to the Baboquivari, Gu Vo and Hickiwan  
10 Districts of the Papago Reservation.

11 The foregoing Resolution was duly enacted by the Papago Council on the 10th  
12 day of March, 1983, at a meeting at which a quorum was present with a vote  
13 of 1148.0 for; 0 against; 0 not voting; and 0 absent,  
14 pursuant to the authority vested in the Papago Council by Section 2 (a) of  
15 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
16 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
17 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
18 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
19 review by the Secretary of the Interior and is effective as of the date of  
20 its enactment by the Papago Council.
