

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Tax Equity and Fiscal Responsibility Act

RES. NO. 32-83

1 WHEREAS, the Tax Equity and Fiscal Responsibility Act of 1982 has a
2 provision requiring all public savings institutions to withhold,
3 as of July 1, 1983, ten percent of all interest payable to all
4 interest bearing accounts for federal income tax purposes; and

5 WHEREAS, regardless of the exception provided in the law, this provision
6 will create hardships and increase inequities in the federal
7 income tax system that should not be placed upon the taxpayers
8 of this country.


9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it joins with
10 banks, savings institutions, industry and other citizens in
11 petitioning the Congress and President of the United States to
12 repeal the provision of the Tax Equity and Fiscal Responsibility
13 Act of 1982 requiring the withholdings for income tax purposes
14 of ten percent of interest payable to interest bearing accounts.

15 The foregoing Resolution was duly enacted by the Papago Council on the 10th
16 day of March, 1983, at a meeting at which a quorum was present with a vote
of 1148.0 for; 0 against; 0 not voting; and 0 absent
17 pursuant to the authority vested in the Papago Council by Section 2 (a) and
18 (h) of Article V of the Constitution and By-laws of the Papago Tribe of
19 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
20 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resoluiton is
not subject to review by the Secretary of the Interior and is effective as
of the date of its enactment by the Papago Council.
