

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Schuk Toak District Revenue Sharing Budget

RES. NO. 33-83

1 WHEREAS, the Papago Council has allocated \$11,642.45 of federal revenue
2 sharing funds to the Schuk Toak District; and

3 WHEREAS, the Papago Council has heard evidence concerning the use of
4 such funds pursuant to the requests presented at the public
5 hearing, including a resolution of the District Council of
6 the Schuk Toak District recommending an equal distribution
7 of \$1,293.60 to each of the District's communities.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the \$11,642.45
9 of federal revenue sharing funds allocated to the Schuk Toak
10 District be distributed in accordance with the requests
11 presented at the public hearing equally, in the sum of
12 \$1,293.60, to the following communities of the District, to-wit:



16 The foregoing Resolution was duly enacted by the Papago Council on the 10th
17 day of March, 1983, at a meeting at which a quorum was present with a vote
18 of 423.5 for; 422.0 against; 302.5 not voting; and 0 absent,
19 pursuant to the authority vested in the Papago Council by Section 2 (a) and
20 (d) of Article V of the Constitution and By-laws of the Papago Tribe of
Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
not subject to review by the Secretary of the Interior and is effective as
of the date of its enactment by the Papago Council.
