15 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above  
 16 named applicants are eligible for enrollment as members of the  
 17 Papago Tribe under Section 1 (a) or (b) of Article II of the  
 18 Papago Constitution and By-laws, as amended, and their  
 19 applications are approved, as herein above indicated.

20 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
 21 the Papago Tribe reduce this final determination in writing  
 22 regarding each of the foregoing applications for enrollment in  
 23 accordance with Section 1 (C) of Article VIII of the Papago  
 24 Enrollment Ordinance; give notice of this Council's determination  
 25 in accordance with Section 2 (a) and (b) of Article VIII of the  
 26 Papago Enrollment Ordinance; and place the names of each applicant  
 27 upon the Tribal Membership Roll in accordance with Article IX of  
 28 the Papago Enrollment Ordinance.

29 The foregoing Resolution was duly enacted by the Papago Council on the 11th  
 30 day of March, 1983, at a meeting at which a quorum was present with a vote of  
 31 1106.5 for; 0 against; 41.5 not voting; and 0 absent,  
 32 pursuant to the authority vested in the Papago Council by Article II and  
 Article V, Section 2 (f) of the Constitution and By-laws of the Papago  
 Tribe of Arizona as amended, ratified by the Papago Tribe on December 12,  
 1936, and approved by the Secretary of the Interior on January 6, 1937,


