

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Reallocating \$60,000. from Agri. to IIM & Realty

RES. NO. 43-83

1 WHEREAS, the Papago Council has been informed by the Superintendent of
2 the Papago Agency, Bureau of Indian Affairs, that the offices
3 of Realty and IIM are anticipating a substantial increase in
4 their workload; and


5 WHEREAS, the Papago Council does see a need to increase the number of
6 staff in both the Realty and IIM offices; and

7 WHEREAS, the Papago Council does wish to re-allocate \$60,000. from the
8 Agriculture (Land Operations) Branch for the Realty and IIM
9 offices.


10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does wish
11 to re-allocate \$60,000. from the Agriculture (Land Operations)
12 Branch for the Realty and IIM Offices.

13 The foregoing Resolution was duly enacted by the Papago Council on the 31st
14 day of March, 1983, at a meeting at which a quorum was present with a vote of
15 1148.0 for; 0 against; 0 not voting; and 5 absent,
16 pursuant to the authority vested in the Papago Council by Section 2 (d) of
17 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
19 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
20 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
21 review by the Secretary of the Interior and is effective as of the date of
22 its enactment by the Papago Council.
