12		Act and has accordingly approved the attached amended FY 1983				
13		budget for the Enrollment Program; and				
14	WHEREAS,	the Papago Council has determined that it is necessary for the				
15		Secretary to make available to the Tribe the sum of \$160,000.00,				
16		pursuant to the attached budget, from the funds held and				
17		administered by the Secretary under the Act for per capita				
18		distribution in order to assist the Tribe to bring the membership				
19		roll current.				
20	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby					
21		request the Secretary of Interior to make available to the				
22		Papago Tribe the sum of \$160,000.00, pursuant to the attached				
23		amended FY 1983 budget for the Enrollment Program, from the				
24		funds held and administered by the Secretary under the Act for				
25		per capita distribution in order to assist the Tribe to bring
