

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Amend Proposed Budget/to add Planning Department

RES. NO. 47-83

1 WHEREAS, the Papago Council believes that it is essential that the Planning
2 Department of the Papago Tribe be increased in order to advise the
3 Council on the best uses of the funds available to the Tribe under
4 the Act of January 3, 1983, P.L. 97-408, before the Council makes
5 its decision on a proposed amendment of the FY 1983 Budget of the
6 Papago Tribe.

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that a proposed amended
8 budget be prepared and submitted to the Council for review which
9 will include funds necessary to expand the Planning Department in
10 order to permit it to advise the Council on the best uses for the
11 funds available to the Tribe pursuant to the Act of January 3, 1983.

12 The foregoing Resolution was duly enacted by the Papago Council on the 7th
13 day of April, 1983, at a meeting at which a quorum was present with a vote
14 of 1086.5 for; 0 against; 61.5 not voting; and 3 absent,
15 pursuant to the authority vested in the Papago Council by Section 2 (f) of
16 Article V of the Constitution and By-laws of the Papago Tribe on December 12,
1936, and approved by the Secretary of the Interior on January 6, 1937,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
Resolution is not subject to review by the Secretary of the Interior and is
effective as of the date of its enactment by the Papago Council.
