NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 7 8 approve of the attached Planning Budget for the remaining five 9 (5) months of the Tribe's 1983 fiscal year, to be incorporated 10 into the Tribe's amended FY 1983 budget. 11 The foregoing Resolution was duly enacted by the Papago Council on the 8th day of April, 1983, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 against; 0 not voting; and 2 absent pursuant to the authority vested in the Papago Council by Section 2 (f) of 12 of 1148.0 for; absent, Article V of the Constitution and By-laws of the Papago Tribe of Arizona as 13 amended, ratified by the Papago Tribe on December 12, 1936, and approved by 14 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
