

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Requesting Timely Per Capita Distributions

RES. NO. 54-83

1 WHEREAS, the Act of January 3, 1983, P.L. 97-408 (96 Stat. 2035) (the "Act"),  
2 providing for the use and distribution of judgment funds awarded to  
3 the Papago Tribe in dockets numbered 345 and 102 of the Indian Claims  
4 Commission, provides that the Secretary of Interior ("Secretary")  
5 shall make initial per capita distributions of \$1,000.00 to members  
6 of the Tribe whose membership applications were approved by this  
7 Council on or before January 3, 1983, within forty-five days after  
8 the date of certification by the Secretary of their eligibility to  
9 share therein, and to members of the Tribe whose applications were  
10 approved by the Council after January 3, 1983, within ninety days  
11 after their applications have been approved by this Council and  
12 their eligibility to share therein has been certified by the  
13 Secretary; and

14 WHEREAS, the purpose of the Act was to make per capita distributions immedi-  
15 ately available to members of the Papago Tribe whose applications  
16 have been approved by the Council and whose eligibility to share  
17 therein has been certified by the Secretary, without waiting for  
18 the completion of a corrected base roll or of the membership roll.

19 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Secretary make  
20 per capita distributions to members of the Papago Tribe as soon as  
21 the Papago Council has approved their membership and their eligi-  
22 bility to share therein can reasonably be certified by the Secretary.

23 BE IT FURTHER RESOLVED that the Secretary not delay the certification of the  
24 eligibility of members of the Tribe to share in per capita distri-  
25 butions, or delay the distributions of per capita payments in order  
26 to meet any enrollment standards or requirements which are not  
27 essential to such certification or to maximize investment interest  
28 or income accruing to the funds held and administered by the  
29 Secretary for per capita distributions under the Act.

30 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
31 day of April, 1983, at a meeting at which a quorum was present with a vote of  
32 1148.0 for; 0 against; 0 not voting; and 2 absent,  
pursuant to the authority vested in the Papago Council by Section 2 (a), (d)  
and (h) of Article V of the Constitution and By-laws of the Papago Tribe of

1 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and  
2 approved by the Secretary of the Interior on January 6, 1937, pursuant to  
3 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
4 not subject to review by the Secretary of the Interior and is effective as  
5 of the date of its enactment by the Papago Council.
