WHEREAS, the San Lucy District Council has by Resolution No. 31-83 requested the Papago Council to waive its claim to one-half of the proceeds accruing under the terms of a lease with Mr. Stephen King; and

WHEREAS, the Papago Council believes that any waiver of lease payments due the Papago Tribe should be uniformily applied.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the request of the San Lucy District Council is tabled until the next regular meeting of this Council, at which time it will be reconsidered together with an ordinance which will provide for the uniform relinquishment by the Papago Tribe of lease payments executed by a District Council.

The foregoing Resolution was duly enacted by the Papago Council on the 11th day of April, 1983, at a meeting at which a quorum was present with a vote of 651.0 for; 272.0 against; 225.0 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
