

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Negotiate Purchase of Land/San Lucy Village

RES. NO. 63-83

1 WHEREAS, Mr. Ernie Jordan has offered to sell 234.4 acres of land lying  
2 East of San Lucy Village to the Papago Tribe for \$1,550.00 per  
3 acre, or the sum of \$363,320.00, upon the following terms:

4 \$ 35,000. upon execution of the agreement  
5 164,160. upon closing of sale  
6 164,160. 14 months after closing  
7 363,320. total purchase price; and

7 WHEREAS, the San Lucy District has determined that there is a dire need  
8 for more land to provide members of the District with homesites  
9 and business resources, and that it would be to the benefit of  
10 the Papago Tribe as a whole that such land be acquired by the  
11 Tribe and added to the Papago Reservation.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
13 authorize the appropriate officers, attorneys and agents of the  
14 Papago Tribe to negotiate the purchase of the land from Mr.  
15 Ernie Jordan, and does hereby request the Bureau of Indian  
16 Affairs to provide the Tribe with expert advice in the contract  
17 negotiations.

18 The foregoing Resolution was duly enacted by the Papago Council on the 11th  
19 day of April, 1983, at a meeting at which a quorum was present with a vote  
20 of 1148.0 for; 0 against; 0 not voting; and 0 absent,  
21 pursuant to the authority vested in the Papago Council by Section 2 (a) of  
22 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
23 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
review by the Secretary of the Interior and is effective as of the date of  
its enactment by the Papago Council.
