

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Recontract with IHS - Management of Health Services

RES. NO. 66-83

1 WHEREAS, the Papago Tribe of Arizona is presently operating the following
2 programs under FY 1982 P. L. 93-638 service contracts with the
3 Public Health, Indian Health Service;

4 MANAGEMENT OF HEALTH SERVICES; and

5 WHEREAS, such Tribal operations has been successful and beneficial to
6 the Papago Tribe and its people; and

7 WHEREAS, it is extremely important that Management of Health Services be
8 retained for the benefit of the Papago people; and

9 WHEREAS, 25 C.F.R. 371.20 of the Federal Regulations require that all
10 proposals to recontract under P. L. 93-638 be submitted to
11 the Tribal Council for approval at least 120 days prior to the
12 contract termination; and

13 WHEREAS, the Papago Council does desire to recontract for provision
14 of these services during FY 1983.

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does
16 authorize and request the Public Health, Indian Health Service
17 to contract with the Papago Tribe under P. L. 93-638 regulations
18 and procedures for the provision of services titled:

19 249-82-0009 MANAGEMENT OF HEALTH SERVICES.

20 BE IT FURTHER RESOLVED that the duration of these contracts shall be
21 from June 1, 1983 through September 30, 1983, unless extended
22 by mutual agreement of both parties.

23 BE IT FURTHER RESOLVED that in the event that this contract does not
24 become effective on June 1, 1983, continuation of this program
25 will be based on an extension of the existing 1982 contract
26 until such time that the 1983 contract becomes effective.


27 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate
28 programs for which contracts are requested herewith which have
29 not been negotiated and executed by the Indian Health Service
30 prior to the start of the funding year.

31 BE IT FURTHER RESOLVED that Max H. Norris, Chairman, or in his absence,
32 Enos J. Francisco, Jr., Vice Chairman or Rosita Ruiz, Treasurer,


1 is hereby authorized to negotiate and execute these contracts
2 and any amendments thereto for the duration of the contract.

3 The foregoing Resolution was duly enacted by the Papago Council on the 11th
4 day of April, 1983, at a meeting at which a quorum was present with a vote
5 of 997.0 for; 0 against; 0 not voting; and 5 absent,
6 pursuant to the authority vested in the Papago Council by Section 2 (d), (e)
7 and (f) of Article V of the Constitution and By-laws of the Papago Tribe of
8 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
9 approved by the Secretary of the Interior on January 6, 1937, pursuant to
10 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
11 not subject to review by the Secretary of the Interior and is effective as
12 of the date of its enactment by the Papago Council.
