

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Request to Recontract P.L. 93-638/IHS

RES. NO. 73-83

1 WHEREAS, the Papago Tribe of Arizona is presently operating the following
2 program under FY 83 P.L. 93-638 service contract with the Public
3 Health, Indian Health Service:

Papago Psychological Service

4 WHEREAS, such Tribal operations have been successful and beneficial to the
5 Papago Tribe and its people; and

6 WHEREAS, 25 CFR Sec. 371.20 of the Federal Regulations require that all
7 proposals to recontract under P.L. 93-638 be submitted to the Tribal
8 Council for approval at least 120 days prior to the contract
9 termination; and

10 WHEREAS, the Papago Tribal Council does desire to recontract for provision
11 of these services during FY 84.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does
13 authorize and request the Public Health, Indian Health Service to
14 contract with the Papago Tribe under P.L. 93-638 regulations and
15 procedures for the provision of services titled:

249-82-0008 Papago Psychological Service

16 BE IT FURTHER RESOLVED that the duration of this contract shall be from
17 October 1, 1983 through September 30, 1984, unless extended by
18 mutual agreement of both parties.

19 BE IT FURTHER RESOLVED that in the event that this contract does not become
20 effective on October 1, 1983, continuation of this program will be
21 based on an extension of the existing 1983 contract until such time
22 that the 84 contract becomes effective.

23 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate a
24 program for which a contract is requested herewith and that has
25 not been negotiated and executed by the Indian Health Service
26 prior to the start of the funding year.

27 BE IT FURTHER RESOLVED that Max H. Norris, Chairman, or in his absence, Enos
28 J. Francisco, Jr., Vice Chairman or Rosita Ruiz, Treasurer, is
29 hereby authorized to negotiate and execute this contract and any
30 amendments thereto for the duration of the contract.

31 The foregoing Resolution was duly enacted by the Papago Council on the 5th
32 day of May, 1983, at a meeting at which a quorum was present with a vote of
1106.5 for; 0 against; 41.5 not voting; and 1 absent,
pursuant to the authority vested in the Papago Council by Section 2 (a) and
(d) of Article V of the Constitution and By-laws of the Papago Tribe of
Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
not subject to review by the Secretary of the Interior and is effective as
of the date of its enactment by the Papago Council.
