## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL Making Additions to Official Census Rolls

RES. NO. 76-83

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe, as amended, provides that the Papago Council can make additions and 2 3 changes to the official census rolls of the Sells and Gila Bend Reservations dated January 1, 1937, and of the San Xavier Reserva-4 tion dated January 1, 1940, subject to the approval of the 5 6 Secretary of the Interior; and WHEREAS, the Enrollment Committee has determined that the following named 7 persons were members of the Papago Tribe on the date of the 8 respective census rolls but that their names had been inadvertently 9 omitted therefrom, and has recommended that their names be added 10 11 to the rolls; and 12

WHEREAS, the Papago Council has reviewed the recommendations of the Enrollment Committee and approves thereof.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the approval of the Secretary of the Interior, the names of the following persons be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation, to-wit:

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
