

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Making Additions to Official Census Rolls

RES. NO. 76-83

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe,
2 as amended, provides that the Papago Council can make additions and
3 changes to the official census rolls of the Sells and Gila Bend
4 Reservations dated January 1, 1937, and of the San Xavier Reserva-
5 tion dated January 1, 1940, subject to the approval of the
6 Secretary of the Interior; and

7 WHEREAS, the Enrollment Committee has determined that the following named
8 persons were members of the Papago Tribe on the date of the
9 respective census rolls but that their names had been inadvertently
10 omitted therefrom, and has recommended that their names be added
11 to the rolls; and

12 WHEREAS, the Papago Council has reviewed the recommendations of the
13 Enrollment Committee and approves thereof.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the
15 approval of the Secretary of the Interior, the names of the
16 following persons be added to the official census rolls of the
17 Sells, Gila Bend or San Xavier Reservation, to-wit:

32 to such rolls.


1 The foregoing Resolution was duly enacted by the Papago Council on the 6th
2 day of May, 1983, at a meeting at which a quorum was present with a vote of
3 880.0 for; 41.5 against; 222.5 not voting; and 0 absent,
4 pursuant to the authority vested in the Papago Council by Section 1 (a) of
5 Article II and Section 2 (f) of Article V of the Constitution and By-laws
6 of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on
7 December 12, 1936, and approved by the Secretary of the Interior on January
8 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
9 Said Resolution is not subject to review by the Secretary of the Interior
10 and is effective as of the date of its enactment by the Papago Council.
