

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

May 28, 1983, General Election

RES. NO. 86-83

1 WHEREAS, the Papago Tribe did on Saturday, May 28, 1983, have a General
2 Election for the offices of Chairman and Vice Chairman and
3 Representatives and Alternates to the Papago Council, and for
4 the offices of Representatives and Alternates to the District
Councils; and

5 WHEREAS, the Papago Election Board did issue and post its Certificates
6 of Election Results in accordance with Section 4(J) of Article
7 VI of the Uniform Election Ordinance, certifying to the
8 election of the candidates who received the highest number of
votes for elective office; and

9 WHEREAS, under Section 4(M) of Article VI of the Uniform Election Ordinance,
10 it is incumbent upon the Papago Council to issue Certificates
11 of Election to the candidates who received the highest
12 number of votes for each office or Council seat within 10 days
13 after the Election Board has posted its Certificates of Election
Results unless an election contest statement is filed within
the time allowed and provided.

14 NOW, THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL that the Chairman
15 and Secretary of the Papago Council are hereby authorized and
16 directed on behalf of the Papago Council to execute and deliver
17 a Certificate of Election to the following persons elected
18 either at large as Chairman and Vice Chairman of the Papago
19 Council, or from their respective Districts as Representatives
20 and Alternates to the Papago Council, who shall hold offices
for a term of four (4) years and until their successors are
certified and seated, to-wit:



The foregoing Resolution was duly enacted by the Papago Council on the 3rd day of June, 1983, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 against; 0 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (c) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
