
16 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the
17 above named applicants are eligible for enrollment as members
18 of the Papago Tribe under Section 1 (a) or (b) of Article II
19 of the Papago Constitution and By-laws, as amended, and their
applications are approved, as herein above indicated.

20 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers
21 of the Papago Tribe reduce this final determination in writing
22 regarding each of the foregoing applications for enrollment in
23 accordance with Section 1 (C) of Article VIII of the Papago
24 Enrollment Ordinance; give notice of this Council's determina-
25 tion in accordance with Section 2 (a) and (b) of Article VIII
of the Papago Enrollment Ordinance; and place the names of
each applicant upon the Tribal Membership Roll in accordance
with Article IX of the Papago Enrollment Ordinance.

26 The foregoing Resolution was duly enacted by the Papago Council on the 24th
27 day of June, 1983, at a meeting at which a quorum was present with a vote of
28 1440.0 for; 0 against; 0 not voting; and 1 absent,
29 pursuant to the authority vested in the Papago Council by Article II and
30 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
of Arizona as amended, ratified by the Papago Tribe on December 12, 1936,
and approved by the Secretary of the Interior on January 6, 1937, pursuant
31 to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
is not subject to review by the Secretary of the Interior and is effective
as of the date of its enactment by the Papago Council.


