

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Authorizing installation and operation of bingo  
video equipment in San Xavier bingo hall)

RES. NO. 06-85

1 WHEREAS, Bingo Partners, an Arizona general partnership, is the Manager of the  
2 Bingo Operation operated by the Papago Tribe on the San Xavier Reser-  
3 vation pursuant to a Management Agreement dated June 1, 1983; and

4 WHEREAS, The Papago Council has been advised by Bingo Partners that P. L. Game  
5 Technology provides bingo video equipment to the bingo hall of the  
6 Fort McDowell Indian Reservation and that it will be necessary for the  
7 Papago Tribe's Bingo Operation if it is to remain financially viable;  
8 and

9 WHEREAS, The Papago Council has been advised that there may be some doubt as to  
10 the legality of operating such equipment on an Indian reservation but  
11 that the Field Representative of the Fort McDowell office of the Bureau  
12 of Indian Affairs had approved such use on the Fort McDowell Indian  
13 Reservation in view of its wide use on other federal reservations, and  
14 that the office of the United States Attorney did advise the Papago  
15 Tribe's General Counsel that it could take no position on the issue of  
16 the legality of operating such equipment until seizure and examination  
17 thereof; and

18 WHEREAS, The Papago Council finds that it is necessary to authorize the instal-  
19 lation and operation of bingo video equipment in the San Xavier bingo  
20 hall as part of the Tribe's Bingo Operation if such operation is to be  
21 and remain financially viable and successful.


22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Bingo Partners is  
23 hereby authorized to install and operate bingo video equipment as part  
24 of the Papago Tribe's Bingo Operation, provided that any revenues and  
25 expenses incurred or derived therefrom be apportioned in accordance  
26 with the provisions of the Management Agreement and provided further  
27 that this authorization shall cease and terminate upon legal determi-  
28 nation that the operation of such equipment on the San Xavier Reser-  
29 vation violates federal law.

30 The foregoing Resolution was duly enacted by the Papago Council on the 09th  
31 day of January, 1985, at a meeting at which a quorum was present with a vote of  
32 931.0 for; 328.5 against; 180.5 not voting; and 1 absent, pursuant  
to the authority vested in the Council by Section 2 (a) (e) (h) and Section 3  
(h) of Article V of the Constitution and By-laws of the Papago Tribe as amended,

1 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
2 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
3 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the se-  
4 cretary of Interior and is effective as of the date of its enactment by the  
5 Papago Council.
