WHEREAS, The Papago Council has been advised by Bingo Partners that P. L. Game
Technology provides bingo video equipment to the bingo hall of the
Fort McDowell Indian Reservation and that it will be necessary for the
Papago Tribe's Bingo Operation if it is to remain financially viable;
and

WHEREAS, The Papago Council has been advised that there may be some doubt as to the legality of operating such equipment on an Indian reservation but that the Field Representative of the Fort McDowell office of the Bureau of Indian Affaris had approved such use on the Fort McDowell Indian Reservation in view of its wide use on other federal reservations, and that the office of the United States Attorney did advise the Papago Tribe's General Counsel that it could take no position on the issue of the legality of operating such equipment until seizure and examination thereof; and

WHEREAS, The Papago Council finds that it is necessary to authorize the installation and operation of bingo video equipment in the San Xavier bingo hall as part of the Tribe's Bingo Operation if such operation is to be and remain financially viable and successful.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Bingo Partners is hereby authorized to install and operate bingo video equipment as part of the Papago Tribe's Bingo Operation, provided that any revenues and expenses incurred or derived therefrom be apportioned in accordance with the provisions of the Management Agreement and provided further that this authorization shall cease and terminate upon legal determination that the operation of such equipment on the San Xavier Reservation violates federal law.

The foregoing Resolution was duly enacted by the Papago Council on the $\underline{09th}$ day of January, 1985, at a meeting at which a quorum was present with a vote of $\underline{931.0}$ for; $\underline{328.5}$ against; $\underline{180.5}$ not voting; and $\underline{1}$ absent, pursuant to the authority vested in the Council by Section 2 (a) (e) (h) abd Section 3 (h) of Article V of the Constitution and By-laws of the Papago Tribe as amended,
