15 approved, as herein above indicated.

16 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the  
17 Papago Tribe reduce this final determination in writing regarding each  
18 of the foregoing applications for enrollment in accordance with Section  
19 3 (c) of Article III of the Papago Tribal Enrollment Ordinance; give  
20 notice of this Council's determination in accordance with Section 4 of  
21 Article III of the Papago Tribal Enrollment Ordinance; and place the  
22 names of each applicant upon the Tribal membership roll in accordance  
23 with Article V of the Papago Tribal Enrollment Ordinance.


24 The foregoing Resolution was duly enacted by the Papago Council on the 09th  
25 day of January, 1985, at a meeting at which a quorum was present with a vote of  
26 1,440.0 for; -0- against; -0- not voting; -0- absent, pursuant to the  
27 authority vested in the Papago Council by Article II and Article V, Section 2  
28 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
29 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
30 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
31 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
32 Secretary of the Interior and is effective as of the date of its enactment by  
the Papago Council.
