NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the application of DAVID U. KING for enrollment as a member of the Papago Tribe is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 14th day of March, 1985, at a meeting at which a quorum was present with a vote of 1,371.0 for; -0- against; 69.0 not voting; and 02 absent; pursuant to
