WHEREAS, The Papago Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the application of MICHAEL D. CARRILLO for enrollment as a member of the Papago Tribe is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the $\underline{15th}$ day of March, 1985, at a meeting at which a quorum was present with a vote of $\underline{1,371.0}$ for; $\underline{-0}$ against; $\underline{69.0}$ not voting; and 03 absent; pursuant to

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
