BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 15th day of March, 1985, at a meeting at which a quorum was present with a vote of 1,302.0 for; -0- against; 138.0 not voting; and 03 absent; pursuant to the
