- BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Papago Enrollment Ordinance.
