16			to submit bids and report back to Council on January 22, and to make attempts to recoup any contract monies from O'odham
17			Construction to put back into Account.
18		2.	The Skill Center will terminate all work on HIP projects effective January 11, 1985.

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
