

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Mountain Bell Right-of-Way Request)

RES. NO. 196-85

1 WHEREAS, Mountain Bells has requested the BIA for a grant of right-of-way for  
2 the placing of telecommunications cables, which right-of-way generally  
3 follows the alignments of the Tucson Nogales Highway and of the I-19  
4 Highway across the San Xavier Reservation and crosses both tribal and  
5 allotted lands; and


6 WHEREAS, The San Xavier District Council has reviewed the request and by Reso-  
7 lution No. 3-85-1 has referred the request to the Papago Council with  
8 the recommendation that PTUA be designated and authorized to negotiate  
9 the terms and conditions of such right-of-way across tribal land for  
10 and on behalf of the Papago Tribe; and

11 WHEREAS, The Papago Council concurs with this recommendation.


12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby desig-  
13 nate and authorize PTUA to negotiate the terms and conditions of the  
14 right-of-way requested by Mountain Bell across tribal land on the San  
15 Xavier Reservation for and on behalf of the Papago Tribe.

16 The foregoing Resolution was duly enacted by the Papago Council on the 10th  
17 day of April, 1985, at a meeting at which a quorum was present with a vote of  
18 1440.0 for; -0- against; -0- not voting and -0- absent, pursuant to the  
19 authority vested in the Papago Council by Section 2(a), (c) and (e) and Section  
20 3 (h) of Article V of the Constitution and By-laws of the Papago Tribe as  
21 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the  
Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by  
the Secretary of the Interior and is effective as of the date of its enactment  
by the Papago Council.
