
11 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above

12 named applicants are eligible for enrollment as members of the Papago  
13 Tribe under Section 1 (a) or (b) of Article II of the Papago Consti-  
14 tution and By-laws, as amended, and that their application are  
15 approved, as herein above indicated.

16 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the  
17 Papago Tribe reduce this final determination in writing regarding each  
18 of the foregoing applications for enrollment in accordance with Section  
19 3 (c) of Article III of the Papago Tribal Enrollment Ordinance; give  
20 notice of this Council's determination in accordance with Section 4  
21 of Article III of the Papago Tribal Enrollment Ordinance; and place  
22 the names of each applicant upon the Tribal membership roll in accor-  
23 dance with Article V of the Papago Tribal Enrollment Ordinance.

24 The foregoing Resolution was duly enacted by the Papago Council on the 11th  
25 day of April, 1985, at a meeting at which a quorum was present with a vote of  
26 1386.5 for; -0- against; 53.5 not voting; and -0- absent, pursuant to  
27 the authority vested in the Papago Council by Article II and Article V, Section  
28 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
29 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
Secretary of the Interior and is effective as of the date of its enactment by  
the Papago Council.
