


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(San Xavier District Budget Amendment FY 85)


1 WHEREAS, The District Council of the San Xavier District did on March 26, 1985,
2 by Resolution No. 3-85-12, & 3-85-13, approve an amendment to its
3 FY 85 District budget in the amount of Eight Thousand Dollars (\$8,000)
4 and One Thousand Dollars (\$1,000);
5 WHEREAS, The San Xavier District Council has reviewed its FY 85 budget and
6 determined that an amendment to the budget is necessary to cover
7 District Council, and Youth per diem not budgeted at the beginning
8 for the fiscal year;
9 WHEREAS, The budget for FY 85 was \$109,764.000 and with the amendment of
10 \$9,000.00 it would bring the San Xavier District FY 85 budget up to
11 \$118,764.00;
12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
13 approve the amendment to the San Xavier District FY 85 budget in the
14 amount of \$9,000.00, such amount to be taken from FY 84 budget savings,
15 and authorizes expenditures in accordance therewith.

16 The foregoing Resolution was duly enacted by the Papago Council on the 11th
17 day of April, 1985, at a meeting at which a quorum was present with a vote of
18 1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
19 authority vested in the Papago Council by Section 2 (f) and Section 3 (a) of
20 Article V of the Constitution of the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
is effective as of the date of its approval by the Superintendent of the Papago
Agency and is subject to review by the Secretary of the Interior.


