8	WHEREAS, There is a need to modify the FY 85 Revenue Sharing budget to include						
9	new line items or to decrease certain line items; and						
10	WHEREAS, The Papago Council has reviewed the proposed changes in the FY 85						
11	revenue sharing budget and approves of the same;						
12	NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby approve						
13	a modification to the FY 85 Revenue Sharing Budget and authorizes						
14	expenditures in accordance with the attached budget.						
15	The foregoing Resolution was duly enacted by the Papago Council on the <u>11th</u> day of April, 1985, at a meeting at which a quorum was present with a vote of						
16	<u>1440.0</u> for; <u>-0-</u> against; <u>-0-</u> not voting; and <u>-0-</u> absent, pursuant to the authority vested in the Papago Council be Section 2 (f) of Article V of the						
17	Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the						
18	Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary						
19	of the Interior and is effective as of the date of its enactment by the Papago Council.
