

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Wise Ones Elderly Program Title III)

RES. NO. 212-85

1 WHEREAS, The Papago Tribe has operated successfully a program for elderly
2 members and residents of the Papago Reservation called the Wise Ones
3 Elderly Program; and

4 WHEREAS, Funding for the Wise Ones Elderly Program has been provided in part
5 by Title III to the Older Americans Act of 1965, as amended through
6 the administration by the Inter Tribal Council of Arizona; and

7 WHEREAS, The Wise Ones Elderly Program will require continued financial
8 assistance to continue providing minimum services to eligible clients;
9 and

10 WHEREAS, The Wise Ones Elderly Program has prepared a proposal for FY 86 for
11 Title III funding to provide transportation, homecare and other
12 support to eligible elderly clients; and

13 WHEREAS, The continued operation of the elderly program will be beneficial to
14 elderly clients;

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves
16 the proposal for Title III funding for the Wise Ones Elderly Program
17 to continue to provide such services as it has proposed in light of
18 the requirements and regulations;

19 BE IT FURTHER RESOLVED that the duration of this contract will be from July
20 01, 1985 through June 30, 1986 unless extended by mutual agreement of
21 both contracting parties;

22 BE IT FURTHER RESOLVED by the Papago Council that the Papago Tribe will not
23 fund or operate the program in the interim while negotiations are
24 still being conducted and no executed contract has been awarded by
25 the Inter Tribal Council of Arizona;

26 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Vice-
27 Chairman or Rosita N. Ruiz, Treasurer are hereby authorized and
28 directed to negotiate and execute any and all contracts, amendments
29 and other necessary documents to secure funding for the continued
30 operation of the Wise Ones Elderly Program.


31 The foregoing Resolution was duly enacted by the Papago Council on the 11th
32 day of April, 1985, at a meeting at which a quorum was present with a vote of
1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the

1 authority vested in the Papago Council by Section 2 (a), (f) and (h) of Article
2 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
3 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
4 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
5 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
6 Secretary of the Interior and is effective as of the date of its enactment by
7 the Papago Council.
