

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Title IV-B Proposal)

RES. NO. 214-85

1 WHEREAS, The Papago Human Services Department has primary responsibility over
2 child welfare services and programs; and

3 WHEREAS, The number of children requiring child welfare services has
4 increased greatly requiring a system for effective and efficient
5 tracking of cases;

7 WHEREAS, Federal funds under Title IV-B is available and can be used in the
8 development of particular child welfare programs;

9 WHEREAS, The Human Services Department proposes to apply for such funds to
10 develop and implement a computer system which will track children,
11 provide case management and create a central registry and data base
12 for future reference and needs;

13 WHEREAS, The nature and sensitivity of child welfare cases requires a
14 separate and confidential system which can only be provided by
15 developing a new system for child welfare programs;

17 WHEREAS, The Papago Human Services department is eligible to apply for Title
18 IV-B funds, such application to be for a three year period;

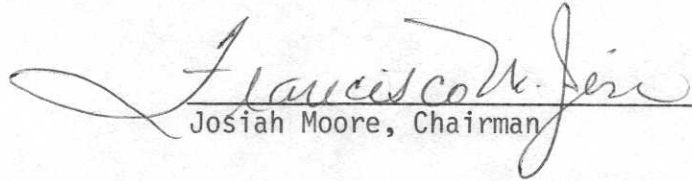
19 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby
20 approve and authorize the Papago Human Services Department to apply
21 for Title IV-B funds over a three year period in accordance with
22 applicable regulations, and hereby directs and authorizes the Chair-
23 man, Josiah Moore, Francisco Jose, Vice-Chairman or Rosita Ruiz,
24 Treasurer, to negotiate and execute any and all contracts, amend-
25 ments thereto and documents necessary to secure funding under Title
26 IV-B for the development of a Child Welfare plan as proposed by the
27 Human Services Department.

29 The foregoing Resolution was duly enacted by the Papago Council on the 11th
30 day of April, 1985, at a meeting at which a quorum was present with a vote of
31 1388.5 for; 51.5 against; -0- not voting; and -0- absent, pursuant to the
32 authority vested in the Papago Council by Section 2 (a) (f) and (h) of Article V
of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
