1	WHEREAS,	An application for enrollment as a member of the Papago Tribe of the
2		Papago Reservation has been filed by or on behalf of Jesus Flores
3		("applicant"), namely application No. 354-GB-74 filed on the 18th day
4		of September, 1984; and

5 WHEREAS, The Enrollment Committee has reviewed the application and has recom-6 mended that the application be denied because the applicant failed to 7 establish the following membership requirement(s): Section 1 (a) or

8 (b) of Article II of the Constitution of the Papago Tribe; and
9 WHEREAS, The application has come on for hearing before this Council; and
10 WHEREAS, The Enrollment Committee did serve written notice of its recommendation
11 to reject the application and of this hearing, as required by Section

12 2, Article VI of the Papago Enrollment Ordinance, upon the person who 13 filed the application and such person was present at this hearing; and 14 WHEREAS, The Papago Council has reviewed all of the evidence presented and from 15 such evidence finds that the applicant has failed to establish the 16 foregoing membership requirement(s).

NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby determine
 that the application of Jesus Flores for enrollment as a member of the
 Papago Tribe is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a
 Certificate of Final Determination of Rejection and that the Enrollment
 Committee serve Notice of Rejection of the application in accordance
 with the provisions of Sections 1 and 2, Article VIII of the Papago
 Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 04th day of February, 1985, at a meeting at which a quorum was present with a vote of 1302.0 for; 138.0 against; -0- not voting; 02 absent, pursuant to the authority vested in the Papago Council by Article II and Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
