

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Rejection of application for adoption of Jesus Flores)

RES. NO. 22-85

1 WHEREAS, An application for adoption as a member of the Papago Tribe of the  
2 Papago Reservation has been filed by or on behalf of Jesus Flores  
3 ("applicant"), namely application No. 354-GB-74 filed on the 18th day  
4 of September, 1985; and

5 WHEREAS, The Enrollment Committee has reviewed the application and has recom-  
6 mended that the application be denied, even though the applicant meets  
7 the blood quantum requirements for adoption of one-half degree or more  
8 of Papago Indian blood set by Section 1 (b) of Article II of the Papago  
9 Constitution; and

10 WHEREAS, The application has come on for hearing before this Council; and

11 WHEREAS, The Enrollment Committee did serve written notice of its recommendation  
12 to reject the application and of this hearing, as required by Section  
13 2, Article VII of the Papago Enrollment Ordinance, upon the person who  
14 filed the application and such person was present at this hearing; and

15 WHEREAS, The Papago Council has reviewed all of the evidence presented and from  
16 such evidence finds that though the applicant meets the blood quantum  
17 requirements for adoption, his/her application should be rejected.

18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby de-  
19 termine that the application of Jesus Flores for adoption as a member  
20 of the Papago Tribe is hereby rejected.


21 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a  
22 Certificate of Final Determination of Rejection and that the Enrollment  
23 Committee serve Notice of Rejection of the application in accordance  
24 with the provisions of Sections 1 and 2, Article VIII of the Papago  
25 Enrollment Ordinance.

26 The foregoing Resolution was duly enacted by the Papago Council on the 04th  
27 day of February, 1985, at a meeting at which a quorum was present with a vote of  
28 -0- for; 1,218.5 against; 221.5 not voting; 02 Absent, pursuant to the  
29 authority vested in the Papago Council by Article II and Section 2 (f) of Article  
30 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
31 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
Secretary of the Interior and is effective as of the date of its enactment by  
the Papago Council.
