


RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Land Acquisition in Florence Village)

RES. NO. 29-85

1 WHEREAS, The Florence Indian Community is a 20 acre addition to the main Papago
2 Reservation; and
3 WHEREAS, The existing land base of the Florence Village is inadequate to serve
4 the growing needs of the families living in the village; and
5 WHEREAS, An opportunity has been presented by Mr. Justin La Font to purchase
6 22,796 acres of land directly adjacent to the present village; and
7 WHEREAS, The District of Gu Achi by Resolution is supporting and requesting
8 assistance in the proposed purchase;
9 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby approve
10 and authorize Tribal officials to begin the process of seeking funds
11 to purchase the La Font property for such purposes as hereafter identi-
12 fied by the District Council and members of the Florence Community.

13 The foregoing Resolution was duly enacted by the Papago Council on the 06th
14 day of February, 1985, at a meeting at which a quorum was present with a vote
15 of 1,440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to
16 the authority vested in the Papago Council by Section 2 (a), (c), and (h) of
17 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
the Secretary of the Interior and is effective as of the date of its enactment
by the Papago Council.
