WHEREAS, An application for enrollment as a member of the Papago Tribe of the the Papago Reservation has been filed by or on behalf of MARISA ANN GARCIA ("applicant"), namely application No. 1059-GV-83 filed on the 21st day of April, 1980; and

WHEREAS, The Enrollment Committee has reviewed the application and has recommended that the application be denied because the applicant failed to establish the following membership requirement(s): PAPAGO CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) & (1B); and

WHEREAS, The application has come on for hearing before this Council; and

WHEREAS, The Enrollment Committee did serve written notice of its recommendation to reject the application and of this hearing, as required by Section 2, Article VI of the Papago Enrollment Ordinance, upon the person who filed the application and such person was not present at this hearing; and

WHEREAS, The Papago Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the application of MARISA ANN GARCIA for enrollment as a member of the Papago Tribe is hereby rejected.


BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 22nd day of April, 1985, at a meeting at which a quorum was present with a vote of 1440.0 for; -0- against; -0- not voting; and -0- absent; pursuant to the

1 authority vested in the Papago Council by Article II and Section 2 (f) of  
2 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
3 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
4 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
5 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
6 review by the Secretary of the Interior and is effective as of the date of  
7 its enactment by the Papago Council.


