

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Rejection of membership application  
of GEORGE G. PASOS)



2 WHEREAS, An application for enrollment as a member of the Papago Tribe of the  
3 the Papago Reservation has been filed by or on behalf of GEORGE G.  
4 PASOS ("applicant"), namely application No. 800-GV-77 filed on the  
5 25th day of April, 1977; and  
6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-  
7 mended that the application be denied because the applicant failed  
8 to establish the following membership requirement(s): PAPAGO  
9 CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) & (1B);  
10 and  
11  
12 WHEREAS, The application has come on for hearing before this Council; and  
13 WHEREAS, The Enrollment Committee did serve written notice of its recommen-  
14 dation to reject the application and of this hearing, as required by  
15 Section 2, Article VI of the Papago Enrollment Ordinance, upon the  
16 person who filed the application and such person was not present at  
17 this hearing; and  
18  
19 WHEREAS, The Papago Council has reviewed all of the evidence presented and  
20 from such evidence finds that the applicant has failed to establish  
21 the foregoing membership requirement(s).  
22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
23 determine that the application of GEORGE G. PASOS for enrollment as  
24 a member of the Papago Tribe is hereby rejected.  
25 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a  
26 certificate of Final Determination of Rejection and that the En-  
27 rollment Committee serve Notice of Rejection of the application in  
28 accordance with the provisions of Section 1 and 2, Article VIII of  
29 of the Papago Enrollment Ordinance.

31 The foregoing Resolution was duly enacted by the Papago Council on the 22nd day  
32 of April, 1985, at a meeting at which a quorum was present with a vote of 1440.0  
for; -0- against; -0- not voting; and 1 absent; pursuant to the
