

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Central Arizona Project Alignment)

RES. NO. 334-85

1 WHEREAS, The Papago Tribe of Arizona signed a Central Arizona Project Indian
2 Water Delivery Contract with the United States on December 11, 1980,
3 thus committing 27,000 acre feet of Colorado River water yearly to
4 the San Xavier Indian Reservation; and

5
6 WHEREAS, The Delivery System identified to transport such quantities of water
7 to the San Xavier Indian Reservation is identified in total as the
8 Central Arizona Project; and

9 WHEREAS, Public Law 97-293, the "Southern Arizona Water Rights Settlement Act
10 of 1982" also provided for the Delivery to the San Xavier Indian
11 Reservation of an additional 23,000 acre feet of Alternative Water
12 Supplies identified in Section 305 of the Act; and

14 WHEREAS, Bureau of Reclamation Officials held two Central Arizona Project
15 Informational Meetings at San Xavier on March 23rd and 30th, 1985
16 regarding the Proposed Alignment of the Main Aqueduct of the Central
17 Arizona Project, Tucson Aqueduct, Phase B, which traverses the San
18 Xavier Indian Reservation; and

19 WHEREAS, Bureau of Reclamation Officials have suggested a Major Structural
20 change from an Open Canal Delivery System (in part) to an All
21 Enclosed Delivery System (pipe) as well as a new location for Water
22 Storage Facilities on the Alignment.

24 NOW, THEREFORE BE IT RESOLVED that the proposed alignment of the Tucson
25 Aqueduct, Phase B, along the north-south mid-section lines of
26 Sections 26 and 35, T.15S, R.12E., G&S.R.B.&M, across Tribal lands
27 within the San Xavier Indian Reservation is approved in principle,
28 and the concept of an Enclosed Buried Pipe Delivery System within
29 the San Xavier Indian Reservation is strongly supported.


30 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and Tribal advisors
31 are hereby authorized to negotiate rights-of-way for the Central

Arizona Project Tucson Aqueduct, Phase B, across Tribal lands within the San Xavier Indian Reservation, and to enter into and execute all necessary contracts and other documents and instruments necessary to carry out the purposes and intent of this resolution.

The foregoing Resolution was duly enacted by the Papago Council on the 08th day of May, 1985, at a meeting at which a quorum was present with a vote of 1,183.0 for; 150.0 against; 107.0 not voting and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (d) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
