

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Authorizing negotiations for acquisition of additional
land for Florence Village)

RES. NO. 336-85

1 WHEREAS, Congress did by the Act of September 10, 1978, P.L. 95-361, 92 Stat.
2 595, add the lands presently constitution the community of Florence
3 village to and make it a part of the Papago Reservation; and

4 WHEREAS, The lands encompassing Florence Village consist of approximately 20
5 acres which have already been fully assigned to members of the com-
6 munity, and additional lands are necessary as homesites for other
7 community members presently without land assignments; and

8 WHEREAS, Mr. Justin LaFont, owner of approximately 22.796 acres of land lying
9 adjacent to Florence Village, has offered to sell such land for
10 \$40,000.00; and

11 WHEREAS, The Gu Achi District Council has urged the prompt acquisition of the
12 land from Mr. LaFont and has appropriated \$20,000.00 of District funds
13 for such acquisition, provided the Papago Council approves thereof and
14 appropriates the balance of funds necessary to purchase the land; and

15 WHEREAS, The Papago Council has determined that the proposed purchase price is
16 reasonable and that there is a great need for additional land to
17 accommodate members of the Florence Village community for whom there
18 is no land on which homesite assignments can be made.

19 NOW, THEREFORE BE IT RESOLVED by the Papapago Council that it does hereby
20 authorize and direct the Chairman, Attorneys and appropriate officers
21 of the Papago Tribe to negotiate on behalf of the Papago Tribe for
22 for the purchase of approximately 22.796 acres of land adjoining
23 Florence Village for a purchase price of approximately \$40,000.00,
24 conditioned upon approval of such acquisition and acceptance of the
25 land by the Secretary of the Interior in trust and as an addition
26 to and part of the Papago Reservation.

27 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize,
28 to be appropriated a sum not to exceed \$25,000.00 as part purchase
29 price and to cover necessary escrow, title and other closing fees and

costs, and does hereby authorize the Chairman, Treasurer and other appropriate officers of the Papago Tribe to disburse \$20,000.00 from the Gu Achi District I.I.M. accounts, previously appropriated by Gu Achi District Council for such purpose, and up to \$25,000.00 from a fund to be identified by the Treasurer of the Papago Tribe, to cover the purchase price and all necessary escrow, title and other closing fees and costs after the purchase contract has been approved by the Papago Council.

BE IT FURTHER RESOLVED that the final negotiated purchase contract shall be presented to the Papago Council for approval.

The foregoing Resolution was duly enacted by the Papago Council on the 08TH day of May, 1985, at a meeting at which a quorum was present with a vote of 1,211.5 for; 228.5 against; -0- not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (e) and 3 (a), (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
