

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Sif Oidak District Revenue Sharing Budget FY 85)

RES. NO. 337-85

1 WHEREAS, The Papago Council has allocated \$15,156.73 of federal revenue
2 sharing funds to the Sif Oidak District; and

3 WHEREAS, The Sif Oidak District has previously been allocated revenue sharing
4 which have remained unexpended, such amount being \$22,292.00

5 WHEREAS, The Papago Council has heard evidence concerning the use of such
6 funds such evidence presented at public hearings, as reflected on
7 the attached resolution of the District Council of the Sif Oidak
8 District; and



10 WHEREAS, The Sif Oidak District Council has proposed a budget for FY 85
11 utilizing Revenue Sharing funds including unexpended amounts;

12 WHEREAS, The Papago Council has reviewed the attached budget and approves of
13 same.

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the \$37,488.73 of
16 federal revenue sharing funds allocated to the Sif Oidak District be
17 distributed in accordance with the requests presented at the public
18 hearing and that it does hereby approve the attached 1985 revenue
19 sharing budget of the Sif Oidak District and authorize expenditures
20 in accordance therewith.

21 The foregoing Resolution was duly enacted by the Papago Council on the 08TH
22 day of May, 1985, at a meeting at which a quorum was present with a vote of
23 1,440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
24 authority vested in the Papago Council by Section 2 (a); (d) of Article V
25 of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
26 ratified by the Papago Tribe on December 12, 1936, and approved by the
27 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the
28 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
29 review by the Secretary of the Interior and is effective as of the date of
30 its enactment by the Papago Council.
