6		actment by the Papago Council; and
8	WHEREAS,	Resolution No. 153-84 was submitted to the Superintendent on October 9
9		1984 three months late, prompting the Superintendent to return the
10		resolution for re-enactment; and
11	WHEREAS.	The Papago Council did on November 7, 1984 reauthorized and re-enacted
12		Resolution 153-84 and submitted to the Superintendent's office on
13		November 15, 1984; and

15	WHEREAS,	The Papago Council did on March 6, 1985 approve and enact Resolution
16		No. 51-85 amending the Sif Oidak District Budget FY 85; and
17	WHEREAS,	This Resolution was presented to the Superintendent for approval who
18		in turn endorsed the Resolution and forwarded the Resolution to the
19		Area Director for his review and approval; and
20 21	WHEREAS,	The Area Director rescinded the Superintendent's March 19th approval
22		of the amendment to the Sif Oidak District FY 85 Budget under the
23		mistaken belief that the District did not have an approved FY 85
24		budget because of the late submittal of Resolution No. 153-84; and
25	WHEREAS,	The Superintendent approving the Re-enactment of Resolution No.
26	2 T . A.	153-84 failed to notify the Area Director of the re-enactment of
27		Resolution No. 153-84 and as a result mistakenly believed the Sif
28		Oidak District FY 85 Budget was not approved.
29	WHEREAS,	The Area Office has recommended that the amendment rescinded by the
30		Area Director be incorporated into the District's budget and

presented to the Papago Council for reauthorization and re-enactment;

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby reauthorize and re-enact Resolution 153-84 and Resolution 51-85, the Sif Oidak District FY 85 Budget and authorizes expenditures in accordance with the budget as amended.

The foregoing Resolution was duly enacted by the Papago Council on the 08th day of May, 1985, at a meeting at which a quorum was present with a vote of 1,379.0 for; -0- against; 61.0 not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2(f) and Section 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
