

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approval of San Lucy District Budget for one month)

RES. NO. 343-85

1 WHEREAS, The Papago Council did by Resolution No. 199-85 approve an advance of
2 tribal funds to the San Lucy District Council for one month under
3 certain terms and conditions; and

4 WHEREAS, Resolution No. 199-85 was submitted to the Superintendent six days
5 late prompting the Superintendent to return the resolution without
6 approval requiring re-enactment; and

7
8 WHEREAS, The Tribal Accounting Office and the San Lucy District have resolved
9 the amount needed to fund the activities for one month, such amount
10 being \$5,238; and

11 WHEREAS, The Papago Council has reviewed the budget and justification for the
12 costs of administering and approves of the same;

13 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does
14 hereby approve the advance of \$5,238 to the San Lucy District for
15 expenses and costs of administering its district programs and
16 activities for one month under the conditions and terms outlined in
17 Resolution No. 199-85, re-enacted by Resolution No. 339-85 and hereby
18 authorizes expenditures in accordance with the attached budget.

20 The foregoing Resolution was duly enacted by the Papago Council on the 09th
21 day of May, 1985, at a meeting at which a quorum was present with a vote of
22 1,333.0 for; -0- against; 707.0 not voting; and -0- absent, pursuant to the
23 authority vested in the Papago Council by Section 2 (f) and 3 (a) of Article
24 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
25 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
26 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of
27 June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of
28 its approval by the Superintendent of the Papago Agency and is subject to
29 review by the Secretary of the Interior.
