

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Base Roll Additions)

RES. NO. 346-85

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe
2 as amended, provides that the Papago Council can make additions and
3 changes to the official census rolls of the Sells and Gila Bend
4 Reservations dated January 1, 1937, and of the San Xavier Reservation
5 dated January 1, 1940, subject to the approval of the Secretary of
6 the Interior; and

7 WHEREAS, The Enrollment Committee has determined that the following named
8 persons were members of the Papago Tribe on the date of the re-
9 spective census rolls but that their names had been inadvertently
10 omitted therefrom, and has recommended that their names be added to
11 the rolls; and

12 WHEREAS, The Papago Council has reviewed the recommendations of the Enrollment
13 Committee and approves thereof.


14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the
15 approval of the Secretary of the Interior, the names of the following
16 persons be added to the official census rolls of the Sells, Gila Bend
17 or San Xavier Reservation, to wit:

20 BE IT FURTHER RESOLVED that the required approval be secured from the Secretary
21 of the Interior before their names be formally added to such rolls.

22 The foregoing Resolution was duly enacted by the Papago Council on the 09th
23 day of May, 1985, at a meeting at which a quorum was present with a vote of
24 1,237.0 for; -0- against; -0- not voting; and 203.0 absent, pursuant to the
25 authority vested in the Papago Council by Article II and Article V, Section
26 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as
27 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
28 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
29 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
30 review by the Secretary of the Interior and is effective as of the date of
31 its enactment by the Papago Council.
