NOW, THEREFORE BE IT RESOLVED that it is hereby determined that the above named applicants are eligible for enrollment as members of the Papago Tribe under Section 2 of Article II of the Papago Constitution and By-laws, as amended, and that their applications are approved, as herein above indicated.

BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Papago Tribe reduce this final determination in writing regarding each of the foregoing applications for enrollment in accordance with Section 3 (c) of Article III of the Papago Tribal Envolument Ordinance; give notice of this Council's determination in accordance with Section 4 of Article III of the Papago Tribal Enrollment Ordinance; and place the names of each applicant upon the Tribal membership roll in accordance with Article V of the Papago Tribal Enrollment Ordinance.

The foregoing Reoslution was duly enacted by the Papago Council on the O9th  $24\,$  day of May, 1985, at a meeting at which a quorum was present with a vote of 1,440.0 for  $\underline{-0}$  against;  $\underline{-0}$  not voting; and  $\underline{-0}$  absent, pursuant to the 25 authority vested in the Papago Council by Article II and Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as 26 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
