10 NOW, THEREFORE BE IT RESOLVED that it is hereby determined that the above named
11 applicants are eligible for enrollment as members of the Papago Tribe
12 under Section 2 of Article II of the Papago Constitution and By-laws,
13 as amended, and that their applications are approved, as herein above
14 indicated.

15 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
16 Papago Tribe reduce this final determination in writing regarding each
17 of the foregoing applications for enrollment in accordance with Section
18 3 (c) of Article III of the Papago Tribal Enrollment Ordinance; give
19 notice of this Council's determination in accordance with Section 4 of
20 Article III of the Papago Tribal Enrollment Ordinance; and place the
21 names of each applicant upon the Tribal membership roll in accordance
22 with Article V of the Papago Tribal Enrollment Ordinance.

23 The foregoing Resolution was duly enacted by the Papago Council on the 09th
24 day of May, 1985, at a meeting at which a quorum was present with a vote of
25 1,440.0 for -0- against; -0- not voting; and -0- absent, pursuant to the
26 authority vested in the Papago Council by Article II and Article V, Section
27 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as
28 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of the Interior and is effective as of the date of
its enactment by the Papago Council.
