

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Amending Papago Enrollment Ordinance)

RES. NO. 349-85

1 WHEREAS, Certain applications for enrollment or adoption have been filed for or
2 on behalf of persons seeking membership in the Papago Tribe, which
3 applications contain either no or incomplete addresses of the
4 applicants or applicants' sponsors, so that, in the processing such
5 applications, the Enrollment Committee is unable to mail or serve upon
6 such applicants or sponsors the notice required by the Papago
7 Enrollment Ordinance; and

9 WHEREAS, The Enrollment Committee has recommended to the Papago Council that
10 the notices required by the Ordinance in the processing of such
11 applications be given by means of publication rather than of personal
12 service or by mail as required by the Ordinance; and

14 WHEREAS, The Papago Council concurs with the recommendation of the Enrollment
15 Committee.


16 NOW, THEREFORE BE IT RESOLVED by the Papago Council that the notices required
17 to be given by Section 2 (d) and (e) of Article VI and by Section 2
18 of Article VII of the Papago Enrollment Ordinance, to applicants or
19 applicants' sponsors upon applications for enrollment or adoption
20 which contain either no or incomplete addresses of the applicants and
21 their sponsors, if any, shall be given to such applicants and/or
22 sponsors by publishing such notices twice in two consecutive publi-
23 cations of a newspaper of general circulation on the Papago Reser-
24 vation, the last of which shall be published at least twenty days
25 prior to the time set for the hearing fixed in the notices.

27 BE IT FURTHER RESOLVED by the Papago Council that the notices required to be
28 given to such applicants and/or sponsors by Section 2 of Article VIII
29 of the Papago Enrollment Ordinance shall be given to them by publish-
30 ing such notices once in a newspaper of general circulation on the
31 Papago Reservation.

1 BE IT FURTHER RESOLVED that the notices published and given in accordance with
2 the provisions of this Resolution shall be in lieu of the notices
3 required by the Papago Enrollment Ordinance and that the Ordinance is
4 hereby amended accordingly.

6 The foregoing Resolution was duly enacted by the Papago Council on the 09th
7 day of May, 1985, at a meeting at which a quorum was present with a vote of
8 1,386.5 for; -0- against; 53.5 not voting; and 02 absent, pursuant to the
9 authority vested in the Papago Council by Section 2 (e), (f) and (h) of
10 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
11 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
12 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
13 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
14 review by the Secretary of the Interior and is effective as of the date of
15 its enactment by the Papago Council.
