RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Amending Papago Enrollment Ordinance)

RES. NO. 349-85

- WHEREAS, Certain applications for enrollment or adoption have been filed for or on behalf of persons seeking membership in the Papago Tribe, which applications contain either no or incomplete addressess of the applicants or applicants' sponsors, so that, in the processing such applications, the Enrollment Committee is unable to mail or serve upon such applicants or sponsors the notice required by the Papago Enrollment Ordinance; and
 - WHEREAS, The Enrollment Committee has recommended to the Papago Council that the notices required by the Ordinance in the processing of such applications be given by means of publication rather than of personal service or by mail as required by the Ordinance; and
 - WHEREAS, The Papago Council concurs with the recommendation of the Enrollment Committee.
 - NOW, THEREFORE BE IT RESOLVED by the Papago Council that the notices required to be given by Section 2 (d) and (e) of Article VI and by Section 2 of Article VII of the Papago Enrollment Ordinance, to applicants or applicants' sponsors upon applications for enrollment or adoption which contain either no or incomplete addresses of the applicants and their sponsors, if any, shall be given to such applicants and/or sponsors by publishing such notices twice in two consecutive publications of a newspaper of general circulation on the Papago Reservation, the last of which shall be published at least twenty days prior to the time set for the hearing fixed in the notices.
 - BE IT FURTHER RESOLVED by the Papago Council that the notices required to be given to such applicants and/or sponsors by Section 2 of Article VIII of the Papago Enrollment Ordinance shall be given to them by publishing such notices once in a newspaper of general circulation on the Papago Reservation.

NO. 349-85 (Amending Papago Enrollment Ordinance) Page Two (2) BE IT FURTHER RESOLVED that the notices published and given in accordance with 2 the provisions of this Resolution shall be in lieu of the notices 3 required by the Papago Enrollment Ordinance and that the Ordinance is 4 hereby amended accordingly. 5 The foregoing Resolution was duly enacted by the Papago Council on the O9th 6 day of May, 1985, at a meeting at which a quorum was present with a vote of 1,386.5 for; -0- against; 53.5 not voting; and 02 absent, pursuant to the authority vested in the Papago Council by Section 2 (e), (f) and (h) of Article V of the Const tution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to 10 review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
