

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Policy and Procedure Budget FY 85)

RES. NO. 355-85

1 WHEREAS, The Papago Council did by Resolution No. 76-85 establish a Policy and
2 Procedures Committee with defined tasks and goals; and


3 WHEREAS, This Committee has prepared an agenda and place of action for the six
4 months requiring the Committee to meet twice a month; and

5 WHEREAS, A budget has been proposed to pay committee members the standard per
6 diem rate authorized by the Papago Council;

8 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby
9 approve the proposed budget of the Policy and Procedures Committee in
10 the amount of \$5,250.00 for six months and authorizes expenditures in
11 accordance therewith; and further directs that such budget be funded
12 from Tribal Council budget of the Papago Tribe.

13 The foregoing Resolution was duly enacted by the Papago Council on the 13th
14 day of May, 1985, at a meeting at which a quorum was present with a vote of
15 909.5 for; 101.5 against; 429.0 not voting; and 01 absent, pursuant to the
16 authority vested in the Papago Council by Section 2 (e), (f) and 3 (a) of
17 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
19 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of
its approval by the Superintendent of the Papago Agency and is subject to review
by the Secretary of the Interior.


